The selection of the participants will be made by the ATTF and its trainers according to the relevance of the participants' profile that will have to correspond to the target group mentioned in the organisation sheet. The applicants should come from **commercial & central banks, financial institutions and supervisory bodies**. The geographical criterion will NOT be considered. The participants are requested to have a **sound knowledge of English** as the whole seminar will be held in that language with no translation.

All successful candidates will be granted a certificate of attendance and a certificate of success after having passed the exam.
We send you herewith the seminar description (organisation sheet & content) and application form.

When and where will the seminar take place?

The seminar will be held in **Luxembourg from Monday 06 to Tuesday 14 October 2014** (arrival date: Sunday, October 05, departure date: Wednesday, October 15). The seminar will end with multiple choice questions, a few open questions and a business case assessment (group presentation of a case in the presence of a jury).

Fees

ATTF is asking for a contribution for the participation in this multinational seminar. This contribution amounts to 140 € excl. VAT per participant per working day (7 x 140 € = 980 € + 3% VAT).
Besides, participants will have to pay a contribution to a travel insurance valid in the Schengen area of 15.45 € VAT included (covering medical costs, repatriation and physical injury insurance). The detail of the covers will be sent together with the confirmation letter in case of selection.

These contributions will have to be paid at the **latest by 15 September 2014**. There will be no refund in case of cancellation after this date.

The Luxembourg Ministry of Finance will cover the experts' and management fees / the accommodation (night and breakfast) / the lunches on seminar days / the closing cocktail/ the visit of the city and of the country / the transportation within the framework of the programme (from and to the airport, to and from the hotel to the venue of the seminar, to and from the closing dinner, tour of the country).

The participants will have to pay their contribution (980 € + 15 € + 3% VAT) / their flight tickets / dinners on seminar days / lunches and dinners



during the weekend / telephone, Internet, pay-TV, additional services in the hotel / transportation for their personal needs.
