## ACI DEALING CERTIFICATE PREPARATION COURSE

The House of Training ([www.houseoftraining.lu](http://www.houseoftraining.lu)) is pleased to inform you that it will organize in early 2018 in cooperation with ACI Luxembourg ([www.acilux.com](http://www.acilux.com)) a preparation course to the "**ACI Dealing Certificate**", a worldwide recognized examination organized by ACI – the International Financial Markets Association.



The ACI Dealing Certificate is a foundation programme that allows candidates to acquire a working knowledge of the structure and operation of the major foreign exchange and money markets, including the ability to apply the fundamental mathematics used in these markets and their core products (cash, forwards and derivatives) and to develop the relevant the basic skills required to compete in these markets.

The ACI Dealing Certificate is a precursor to the ACI Diploma.

### When and where?

The ACI Dealing Certificate preparation course, supported by the **Luxembourg Government**, will be organized **in Luxembourg from 29 January to 2 February 2018** (arrival 27 Jan, departure 3 Feb).



The course will be held by a senior training expert in foreign exchange with experience in dealing rooms and willing to share his expertise in this field.

### Who should attend?

The course is dedicated to **Recent Entrants and Junior Dealers** (0-18 months experience in a dealing room), **Middle Office and Operations Personnel, Auditors and Compliance Officers**.

The course will be open to participants selected by the House of Training/ATTF and ACI Luxembourg experts. The selection will be based on objective criteria such as the applicants' present function as well as their professional and educational background. The geographical location will not be a selection factor. A **very good knowledge of English** is required.

Please note that priority will be given to candidates who intend to take the ACI Dealing Certificate exam in a near future.


