Scholarships granted by the Luxembourg Ministry of Finance to attend the online “CAMFIN - Capital Markets and Financial Instruments Certificate”

For many years, the well-known CAMFIN seminar has been offering a great opportunity to professionals from the House of Training-ATTF partner countries to thoroughly deepen their knowledge of the international capital markets and of the financial instruments.

After a one-year break due to the pandemic, we are now delighted to be able to offer an online version of this certifying programme, organized in cooperation with ICMA Luxembourg region.

On behalf of the Luxembourg Ministry of Finance, the House of Training-ATTF is pleased to offer **up to 10 free places for this programme** (please see the Financial Conditions appendix).

The programme combines 2 parts:

PART 1: E-Learning preparation courses “International Financial Markets” and “Financial Mathematics”

The E-learning courses are a **prerequisite** for the “CAMFIN Certificate”. They will be made available about one month before the start of the online course.

Estimated duration:

- International financial markets: 2 hours
- Financial mathematics: 8 hours

PART 2: Principal online seminar

The course will be delivered online in 10 sessions of 4 hours each, from 14 to 29 June 2021. The programme will end with an online exam on 1 July 2021. All successful candidates will be granted an electronic certificate of achievement.

The participants are requested to have a **sound knowledge of English**.

Please note that all the selected candidates will have to be equipped with a well-functioning microphone and a **webcam**.


