Online "CAMFIN - Capital Markets and Financial Instruments Certificate" 12– 29 June 2023

Dear Madam, Sir,

For many years, the well-known CAMFIN seminar has been offering a great opportunity to professionals from the House of Training-ATTF partner countries to deepen their knowledge of the international capital markets and of the financial instruments thoroughly.

After a one-year break due to the pandemic, the House of Training resumed the seminar online in 2021 and we are pleased to announce a success rate of 94% and 100% for the editions organised in 2021 and of 91% in 2022. In 2023 the online programme will take place only once, in June, and will consist of two parts:

PART 1: E-Learning preparation courses

Completing the two e-learning courses "International financial markets" and "Financial mathematics" is a **prerequisite** to receive the "CAMFIN Certificate". These e-learning courses will be made available at the latest two weeks before the start of the online course, provided the contribution fees have been paid – see attached Financial Conditions, and take 10 hours to complete (2 resp. 8 hours respectively).

PART 2: Online seminar

The course will be delivered online in 10 sessions of 4 hours each, **from 12 to 15 June, from 19 to 22 June and from 26 to 27 June 2022**. The programme will end with an **online exam on 29 June 2022**. All successful candidates will be granted an electronic certificate of achievement.

This certification programme, supported by the **Luxembourg Ministry of Finance**, will be delivered by senior experts with an in-depth experience and willing to share their expertise in their field.

Up to 12 candidates will be selected among applicants from the different invited countries. The selection will be made by the House of Training and its experts, according to the relevance of the participants' profiles (which will have to correspond to the programme target audience) and motivations. The participants are requested to have a **sound knowledge of English**. The selected candidates will have to be equipped with well-functioning microphones and **webcams**.

We invite you to have a look at the attached documents to get more details on the programme and the financial conditions. In order to promote access to this unique learning opportunity, we have made sure that the financial support of the Luxembourg Ministry of Finance is kept at its highest level.


