## PREPARATION COURSE TO THE CERTIFIED INFORMATION SECURITY MANAGER® (CISM®) CERTIFICATION – NEW EDITION

Digital transformation has continued to accelerate in recent years and the modern world relies on the digital space to get business done. But with the increase in cyberattacks, scams and security breaches, becoming a digitally trustworthy enterprise is important for organizations to enhance reputations, their relationships and brand loyalty with customers.



Digital trust is a necessity in a global economy reliant on ever-increasing connectivity, data use and new innovative technologies. To help financial organizations of its partner countries to advance digital trust so their business can grow and thrive, the House of Training – ATTF, with the support of the **Luxembourg Ministry of Finance**, is willing to assist their professionals to become strategic security leaders by offering them the opportunity to get ready for the **ISACA's Certified Information Security Manager® (CISM®)** exam.

After the success of our online preparation course over the last two years (pass rate of 88% in 2022 and 72% in 2023), a new edition will be delivered on **3, 5, 7, 10, 12 and 14 June 2024** by a representative of ISACA Luxembourg Chapter. Selected participants will be offered ISACA membership, CISM® review manual, access to a Q&A database as well as a voucher to take the **CISM® exam by 31 August 2024**. The exam is computer-based and administered as a remotely proctored exam or at authorized PSI testing centers globally.

The CISM® Certification indicates expertise in information security governance, program development and management, incident management and risk management. It brings credibility, validate commitment to compliance, security, and integrity, and ensures alignment between the organization's information security program and its broader goals and objectives.

The programme will be open to 18 participants selected by the House of Training-ATTF and ISACA Experts among candidates from our partner countries. It is designed for those who manage, design, oversee and assess an enterprise's information security function. **Five (5) or more years of experience in information security management** are required so that participants who pass the exam may quickly apply for the certification.

The CISM® exam requiring **long-term preparation and intensive self-study** (the review material will be sent to the participants who will have to study in advance), only **highly motivated** candidates, with a **very good command of English**, should apply. A condition to be selected is also to commit to **take the CISM® exam by 31 August 2024**.

If you have technical expertise and experience in IS/IT security and control, want to make the move from team player to manager, if you are ready to dedicate personal time to add credibility and confidence to your interactions with internal and external stakeholders, peers and regulators, don't miss this opportunity for learning and career growth.
