Target Group

Professionals who are interested in or currently working in the financial sector and seeking a certification as a Financial Sector Security Officer. This may include employees from financial institutions such as banks, insurance companies, investment firms, PFS or other organisations operating in the financial industry.

A background and experience in ICT and/or information security is required.

How to apply?

Interested candidates may apply for this programme by filling in the attached application form. We are inviting the candidates to send their applications to our partner in their country (from whom they received the present invitation) by **April 2nd, 2024**.

Selection Process

We will inform our partners of the results of the selection process at the latest on April 12th, 2024.

Only complete applications will be retained. Candidates with the most relevant profiles in reference to the target group and with pertinent motivations are most likely to be selected.

The seminar and the exam will be conducted in English without any translation. Therefore, a very good knowledge of English is essential to ensure all participants maximise their benefit from the course and enhance the chances to pass the exam.

The link for the online examination will be sent at the end of the course. Candidates will have 5 working days to take it, after which the exam will no longer be available. It is therefore mandatory to respect the deadline.


