Multinational Certification Programme « Sustainable Finance »

Dear Sir or Madam,

With an increasing global awareness of environmental and social challenges, the need for financial expertise to bring positive changes is becoming more urgent. Investors and institutions are prioritising sustainability and recognise the importance of environmental management, social responsibility, and strong governance practices for long-term value creation.

For this reason, the House of Training is pleased to inform you that the Luxembourg Ministry of Finance will support the participation of 18 professionals from its partner countries in the fourth session of the Sustainable Finance Certification Programme that will be held **online between 16 October and 6 November 2024** (10 sessions for a total of 32 hours including exam), with an introductory e-learning session (approximately 1 hour of online self-study) to be completed before the start of the online courses. As it has been the case since its conception, this programme has been developed and is kept up to date in cooperation with its partners ABBL, Deloitte, Forethix, Loyens & Loeff, the Luxembourg Green Exchange (LGX), and Luxflag.

The certification is primarily designed for executives, managers, heads of department of banks, asset management, insurance companies and other relevant financial institutions. If you are holding one of these positions and want to find out more about the various stakeholders involved in Sustainable Finance, learn why this topic has increased in importance in the last couple of years, understand the key concepts of sustainable development and climate change, current ESG regulations, get clarity on the currently available products on the Sustainable Finance market, and more, then this training course is for you!

We invite you to read the attached documents to get more details on the programme content, the courses schedule, and the financial conditions.

18 participants will be selected among applicants from the House of Training-ATTF partner countries. The selection will be made by the experts of the ESG Environment, Social and Governance Quality Circle of the House of Training-ATTF, according to the relevance of the participants' profiles and their motivations. The geographical criterion will NOT be considered unless this course is oversubscribed where a quota of places per country may be applied. The participants are requested to have a **sound knowledge of English**, as the whole seminar will be held in this language with no translation.

All successful candidates will be granted the "Sustainable Finance" certificate.
