"Money laundering is the process of making illegally gained proceeds (i.e. "dirty money") appear legal (i.e. "clean"). Typically, it involves three steps: placement, layering and integration. First, the illegitimate funds are furtively introduced into the legitimate financial system. Then, the money is moved around to create confusion, sometimes by wiring or transferring through numerous accounts. Finally, it is integrated into the financial system through additional transactions until the "dirty money" appears "clean." Money laundering can facilitate crimes such as drug trafficking and terrorism and can adversely impact the global economy." (United States Department of the Treasury - FinCen, 2016)

As a professional in Anti-Money Laundering or Compliance, it is your mission to safeguard your bank from the abuses of financial crime, including terrorist financing, money laundering and other illicit activity.

To help you achieve your mission and to give you the needed knowledge and tools to accomplish it in the most professional way, the Luxembourg Fund to Fight Drug Trafficking ("Fonds de lutte contre certaines formes de criminalité") decided to support the participation of 25 professionals from its partner countries in the seminars Anti-Money Laundering & Counter-Terrorist Financing (AML& CTF) Advanced Level & Preparation course to the CAMS® certification exam which will be implemented by the House of Training – ATTF from 17 to 21 February 2025 or from 6 to 10 October 2025.

The programme will be offered entirely online. The exam, however, can be taken on a proxy controlled online format<sup>1</sup> or at a test centre, which is available in most of our partner countries. Selected candidates will receive more information in due time.

# How to apply

Interested professionals are kindly requested to fill in the attached **House of Training-ATTF application form** and to send them back to <u>our official contact in their country</u> (from whom the present invitation was received) **before the 8**<sup>th</sup> **of January 2025**.

<u>If you are selected</u>, the House of Training-ATTF will inform its partner in your country during the week of January 13<sup>th</sup>, 2025. You will then receive the confirmation documents & the invoice.

Mrs Bérengère Delahaut, from ACAMS, will contact you directly in the days following your selection with instruction on how to complete your registration. Once your application is approved and your invoice is paid you will be informed on how to book your online exam.

For your registration to be final you will have to proceed with the following:
