Online courses in collaboration with the HEC Liège Luxembourg February - June 2025

AI is integrating our lives at a rapid pace; it revolutionises industries and reshapes the future, from personal recommendations on streaming platforms to autonomous vehicles navigating our streets. The potential of AI seems endless. Similarly, Blockchain & Big Data represent the cornerstone of digital transformation. It offers unparalleled opportunities for efficiency, transparency, and security. The technology has disrupted traditional business models, enabling trustless transactions and redefining concepts of ownership. Big Data empowers organisations to extract valuable insights from vast volumes of information, driving informed decision-making and strategic advantage.

The House of Training ATTF is therefore pleased to announce that after the successful first editions of 2024, the following exciting multinational Fintech courses will be proposed again in 2025 as part of the collaboration between the House of Training ATTF and the HEC Liège Luxembourg: **AI: Artificial Intelligence** and **Blockchain & Big Data**, which we hope will empower individuals to navigate the complexities of the digital age confidently and unlock the boundless possibilities of AI and Blockchain & Big Data.

The Luxembourg Ministry of Finance will support the participation of five participants in each online course, both of which will be delivered by senior experts with an in-depth experience and willing to share their expertise in their respective fields.

Both courses will be delivered online in **12 sessions of 3 hours** each that will take place from **18.30 to 21.30 Luxembourg time** (CEST or CET; please check if the schedule in your time zone will be affected by Luxembourg start of Daylight-Saving Time in the last weekend of March!); the exact dates for each course can be found in the Course Descriptions that you will find attached.

All participants who attend the entirety of one of these courses will be granted a certificate of completion.

AI: Artificial Intelligence (4 February to 13 June 2025)

This course, developed by the HEC Liège Luxembourg in support of the Luxembourg House of Financial Technology, is a hands-on opportunity to develop effective AI strategies and manage AI strategies within organisations. Offering concrete insights into the challenges and opportunities associated with AI adoption and organisational change, participants will understand the transformative potential of AI in marketing, customer analytics, finance, and the future of work. They will also explore ethical considerations, responsible practices, as well as analytical and critical thinking. They will explore how AI can drive innovation, enhance decision-making, and create value for organisations.

Blockchain & Big Data (5 February to 11 June 2025)

This training focuses on understanding the potential benefits and challenges of using blockchain technology & Quantum Computing in Financial Services, Corporate Entrepreneurship and Fintech by analysing real-world applications individually or in a team. Blockchain & Big Data is organised in collaboration with **Luxembourg House of Finance Technology** (LHoFT).





For each course, up to **5 candidates** will be selected among applicants from the different invited countries. The selection will be made by the House of Training and the HEC Liège Luxembourg, according to the relevance of the participants' profiles (which will have to correspond to the programme target audience) and motivations. The participants are requested to have a **sound knowledge of English**. The selected candidates will have to be equipped with well-functioning **microphones** and **webcams**.

We invite you to have a look at the attached documents to get more details on the programme and the financial conditions. In order to promote access to this unique learning opportunity, we have made sure that the financial support of the Luxembourg Ministry of Finance is kept at its highest level.
