Article 1

The wording “state-owned Joint Stock Company for Performing Energy Activities National Energy Resources Skopje” in the title of the Law on Guarantee by the Republic of North Macedonia under the Finance Contract intended for financing the “Gas

Official Gazette of the Republic of North Macedonia, no. 255 dated 17st December 2024

Interconnector Greece - North Macedonia, North Macedonia Part” Project, to be concluded between the European Investment Bank and the state-owned Joint Stock Company for Performing Energy Activities National Energy Resources Skopje (“Official Gazette of the Republic of North Macedonia”, no. 288/21), shall be replaced with the wording “Joint Stock Company for Performing Energy Activity Natural Gas Transmission NOMAGAS Skopje in state ownership”.

Article 2

The wording “state-owned Joint Stock Company for Performing Energy Activities National Energy Resources Skopje” in Article 1 shall be replaced with the wording “Joint Stock Company for Performing Energy Activity Natural Gas Transmission NOMAGAS Skopje in state ownership”.

Article 3

The wording “state-owned Joint Stock Company for Performing Energy Activities National Energy Resources Skopje” in Article 2 shall be replaced with the wording “Joint Stock Company for Performing Energy Activity Natural Gas Transmission NOMAGAS Skopje in state ownership”.

Article 4

The wording “state-owned Joint Stock Company for Performing Energy Activities National Energy Resources Skopje” in Article 3 shall be replaced with the wording “Joint Stock Company for Performing Energy Activity Natural Gas Transmission NOMAGAS Skopje in state ownership”.

Article 5

The wording “state-owned Joint Stock Company for Performing Energy Activities National Energy Resources Skopje” in Article 5 shall be replaced with the wording “Joint Stock Company for Performing Energy Activity Natural Gas Transmission NOMAGAS Skopje in state ownership”.

Article 6

This Law shall enter into force on the day it is published in the “Official Gazette of the Republic of North Macedonia”.
